**CONDITIONS GOVERNING USE**

All requests for photographic and digital reproductions are governed by the following conditions:

- Reproductions are provided one-time, for personal use, research purposes or publication/exhibition only. Reproductions must be used only for the purpose stated on this form. Additional uses of the same images must be authorized with a new statement of use.
- Images are not to be altered in any way that substantially changes the meaning or compromises the integrity of the images.
- All images used in printed, electronic or digital publications, on film and video, on web sites and in exhibitions must be credited with the following: "Courtesy: Archives of the Galesburg Public Library, Galesburg, Illinois." In those cases where images are being used on an internet page, or the equivalent thereof, the citation should be made into a link to the Galesburg Public Library's homepage at "www.galesburglibrary.org."
- Permission to publish is valid only for the individual, company or institution to whom it is issued and may not be transferred, assigned or sold, without written permission from the Galesburg Public Library.
- The Requester is to deliver to the Galesburg Public Library one complimentary copy of any published work in which the photographic reproduction occurs.
- In authorizing the publication of any reproduction, the Galesburg Public Library does not surrender or limit its own right to publish, exhibit or otherwise reproduce the material, or to grant permission to others.
- **Users assume all responsibility for questions of copyright, invasion of privacy and rights of publicity that may arise in using reproductions from the Galesburg Public Library's collection. The Library reserves the right to refuse to process a reproduction order, if in its judgment, fulfillment of the order would violate copyright law.**
