# Action Items:

**Patron Suspension:** A patron has been consistently breaking the rules at GPL for use of the library. It has come to a suspension for this individual. The patron's situation was discussed, as well as staff comfortability, and the length of the suspension. Similar situations were also discussed. A motion was made by Thorn to approve the suspension, and was seconded by Reichel.

**Richardson Endowment Scholarship Policy:** It is considered that the management of funds related to the Dorothea and William K Richardson Endowment Scholarship, should be abdicated to the GPLF, and as such, the policy regarding its management at GPL will henceforth be retired. A Motion was made by Thorn, and seconded by Reichel. it was unanimously approved by a voice vote.

**March 1 Library Closure:** It is proposed that GPL should close from March 1-31 and open in early April to conduct the business of moving the various collections, furniture, records, and other items, as well as getting settled into the new building. A motion was made by Reichel and seconded by Thorn. The motion was unanimously approved via a voice vote.

**Transfer of Unexpended Funds to Special Reserve** (Ordinance 2011-1-2011): Treasurer Reichel recommended to transfer \$80,000 of unexpended general funds to special reserve funds. A motion was made by Williamson to approve the transfer, and seconded by Thorn. Roll Call was taken, and the motion was unanimously approved.
